PART I. General Expectations

Mesa Verde Elementary agrees to implement the following statutory requirements:

- C. that parents are encouraged to be actively engaged in their child's education and school;
- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how Mesa Verde Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Mesa Verde Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Title I Parent Engagement Advisory Council: These meetings will be offered in English with the assistance of *Language Line* or an interpreter for other language needs and hosted at Mesa Verde Elementary. Prior to reviewing, discussing and amending the plan, each meeting will offer parents' training on what Title I entails and the importance of parent input. Parents will be selected off of a list of parents that have been actively involved at school.

2. Mesa Verde Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Parents are invited to help review and add input to the Campus Improvement Plan. Meetings are held in English with the assistance of *Language Line* or an interpreter for other language needs. Parents are invited based upon involvement in the school.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - These meetings are scheduled after school as needed.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Mesa Verde Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Title I information meeting is held during the beginning and end of Meet and Greet scheduled before school begins. Parents are also given information from teachers that instruct them to come to the office for a handout on Title I information. *Language Line* or an interpreter is available to help with language needs when necessary.

4. Mesa Verde Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- These meetings occur periodically throughout the school year during parent-teacher conferences as well as the Title I meetings at the beginning of the school year. *Language Line*, ELSA, and an interpreter are available upon request and used as needed.

5. Mesa Verde Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- These meetings will be held through-out the year at school functions—(Christmas Sing-along, Thanksgiving Dinner, Book Fair, Parent/Teacher conferences, Special Ed. and 504 meetings, Turkey Trot, Honor Choir concerts, performance orchestra concerts). *Language Line*, ELSA, and an interpreter are available upon request and used as needed.

6. Mesa Verde Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- State assessment results are provided online. Mesa Verde sends out information of how to access the individual student information and offers to help parents to access that information if needed. *Language Line*, ELSA, and an interpreter are available upon request and used as needed.

7. Mesa Verde Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Phone call out system.
- Counselor available to help with physical needs.
- Library open for check out after school hours.

8. Mesa Verde Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. *Language Line*, ELSA, and an interpreter are available upon request and used as needed. These may include, but are not limited to, the following:

- Library Night/Literacy Night.
- Math Night.
- Discovery Center Night.
- Skyward Parent Training.

- On-line registration—with help of interpreters in Swahili, Karen, Burmese, and Somalia.

9. Mesa Verde Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- This will be done during meet and greet, special education meetings, 504 meetings, discipline conferences and teacher/parent conferences. This will also be addressed with phone call system as needed. *Language Line*, ELSA, and an interpreter are available upon request and used as needed.

10. Mesa Verde Elementary will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Mesa Verde Elementary teachers make personal contacts with parents that have children entering Pre-K to help families make a smooth transition. *Language Line*, ELSA, and an interpreter are available upon request and used as needed.

11. Mesa Verde Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- *Language Line*, ELSA, and interpreters are available upon request and used as needed for any meeting or communication.

PART III. Discretionary Components of the Mesa Verde Elementary Title I Parent Engagement Plan

Mesa Verde Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- Providing necessary literacy training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training.
